Legal Aid WA's Family Court Services Unit provides a Duty Lawyer service at the Family Court of WA, Monday to Friday, from 9:00am to 4:00pm. Family Court Services provides free legal advice to self-represented litigants in relation to their parenting matters and provides FASS (Family Advocacy and Support Services) in WA. The Duty Lawyer can represent parties in court on a one-off basis (if they are able to) and, in some cases, can assist with the preparation of urgent applications. There is also an on-site social support worker who can provide associated non-legal support for families experiencing family violence.
